



# Camberwell Girls Grammar School Scholarship Terms and Conditions

Camberwell Girls Grammar School offers a variety of scholarships, including the **Academic Excellence Scholarship, Music/Academic Excellence Scholarship, Principal's Scholarship for Service, First Nations Scholarship** and **Means-Tested Scholarship**. These scholarships are awarded based on various criteria, including academic performance, co-curricular involvement, and, where relevant, musical aptitude or service contributions.

By accepting a scholarship at CGGS, the recipient and their parents or guardians agree to the following terms and conditions.

## 1. Awarding of Scholarships

All scholarships are awarded based on:

- ◆ Results of **academic aptitude** evidenced through academic reports and **scholarship testing**.
- ◆ **Supporting documentation** provided as part of the application by the due date.
- ◆ **Participation** in the **Interactive Scholarship Evening**.
- ◆ An **audition**, where requested by the Scholarship Panel (for Music/Academic Excellence Scholarship applicants).
- ◆ An **interview**, where requested by the Scholarship Panel.

## 2. Eligibility

To be eligible for a scholarship at Camberwell Girls, candidates must meet the following criteria:

- ◆ Be an **Australian or New Zealand Citizen**, or a **Permanent Resident** of Australia.
- ◆ Be entering one of the eligible year levels and satisfy all year level-appropriate requirements as outlined in the specific scholarship criteria.

## 3. Student Responsibilities and Performance

Scholarship recipients are expected to:

- ◆ **Maintain a high standard of academic achievement**, as outlined in the scholarship category.
- ◆ **Contribute fully to the life of the School**, including participation in co-curricular activities and upholding the values of Camberwell Girls: **Integrity, Commitment, Respect, Hope, and Courage**.
- ◆ Scholarship holders' performance will be **reviewed annually**. Camberwell Girls reserves the right to review a scholar's performance at any time and withdraw a scholarship if the recipient does not meet the agreed terms and conditions.

## 4. Means-Tested Scholarships

- ◆ For **Means-Tested Scholarships**, the school reserves the right to request the completion of a financial assistance form each year for the duration of the scholarship. Families may be required to declare their financial position annually.
- ◆ In the event of significant changes to a family's financial circumstances, Camberwell Girls reserves the right to **amend the terms and amount** of the scholarship at its sole discretion.



## 5. Scholarship Tenure and Withdrawal

- ◆ Scholarships are granted with the expectation that recipients will **complete Year 12** at CGGS.
- ◆ In the event of a student's **withdrawal prior to Year 12**, the full value of the scholarship awarded up to that time may be **repayable to the School**.
- ◆ Unless the Scholarship is terminated, the parents/guardians of the Student must pay all billed tuition fees and any other fees or charges in respect of Student less remissions within CGGS's payment requirements.
- ◆ Scholarships may not be **transferred** to a different school year or deferred for future entry, and recipients are expected to use the scholarship for the year level offered.

## 6. Scholarship Exclusivity

- ◆ **No student may hold more than one scholarship** at Camberwell Girls simultaneously.
- ◆ A **sibling discount** does not apply to any scholarship holder.

## 7. Financial and Other School Costs

- ◆ A scholarship deposit of AUD\$3,000 is payable at the time of acceptance of the Scholarship and is credited towards the student's 4th instalment tuition fees in the year the Scholarship commences. This scholarship deposit is non-refundable should your daughter not take up her Scholarship in the school year in which the Scholarship commences and it is non-transferable to a later year of entry.
- ◆ Scholarships generally do not cover additional costs such as the **Infrastructure Levy, consolidated charges, uniforms, books, additional music tuition, or optional camps and tours**.

## 8. Confidentiality

- ◆ All matters related to scholarships, including testing results, interview outcomes, and the awarding process, are **strictly confidential**.
- ◆ Camberwell Girls does not disclose any information regarding scholarship testing, interviews, or assessment criteria to applicants or families.

## 9. Scholarship Panel and Decision Finality

- ◆ All decisions regarding the awarding of scholarships are made by the **Scholarship Panel** at CGGS.
- ◆ All decisions made by the Scholarship Panel are **final**, and no further correspondence will be entered into regarding the outcomes.

## 10. Application Fee

- ◆ All scholarship applications are subject to a **non-refundable application fee** of AUD \$120.00, payable at the time of application via Edutest.

## 11. Contractual Agreement

- ◆ These scholarship terms and conditions form part of the **contract** between CGGS and the parents or guardians who sign the **Offer of Place** at the school. By accepting a scholarship, recipients and their families agree to comply with all the terms and conditions as outlined above.
